
## Overview of CLJA

- CLJA, signed into law on Aug. 10, 2022, is part of the 2022 "Promise to Address Comprehensive Toxics" (PACT) Act. CLJA is in Section 804 of the PACT Act.
- CLJA establishes a separate tort claim against the U.S. Navy handled by the U.S. District Court for the Eastern District of North Carolina.
- CLJA does **not** provide for a claim for VA disability benefits or VA health care; it is a one-time benefit.
- CLJA filing deadline is August 10, 2024.

## Eligibility for CLJA Tort Claim

- Who: CLJA covers Veterans, families, and contractors.
  - Up to one million people.
  - Includes in utero exposure.
- Where: Resided at Camp Lejeune for a total of 30 cumulative days.
- When: From Aug. 1, 1953, to Dec. 31, 1987.

# Understanding "Offset"

- Veterans and their families may be eligible to file **both** a
   VA claim and a CLJA tort claim.
  - VA claim benefit Monthly payments.
  - CLJA tort One-time lump sum payment.
- It is important to note that if a Veteran files both a VA claim and a CLJA tort claim, there may be an offset to prevent the government from paying a Veteran twice for the same condition.
- VA is on record stating that any offset will not be against
   VA benefits. Rather it will come from any CLJA award.
- The offset is described in Section 804(e)(2) of the CLJA –

## Offset, 2

 The text of the CLJA suggests that the offset includes both Medicare or Medicaid benefits and in connection with medical care.

 Any offset of VA benefits will be taken from the CLJA award. This means your VA disability will not be affected.

# TAL – B&M CLJA Relationship



#### **B&M's responsibilities:**

- Limiting / capping attorney fees and costs to one-third of the overall CLJA tort award.
- Educating about the effect of any CLJA settlement on VA benefits, including offsets.
- Recommending the best choice

   a CLJA award and/or a VA
   claim where the Veteran decides.

## TAL – B&M CLJA Relationship



#### TAL's responsibilities:

- Notifying Legionnaires about CLJA and the B&M relationship via national magazine and website.
- Reaching Out to The Legion at Departments with facts about CLJA, including offsets and warning about aggressive firms who are providing Veterans incomplete or possibly misleading information.

## Two-Pronged CLJA Tort Claim Process

# Our goal is for each Veteran to make an informed decision and obtain the maximum VA and CLJA benefits.

- Veteran contacts an accredited service officer and determines the best strategy for maximum VA and CLJA benefits.
- **AND** \*
- Veteran contacts B&M and determines CLJA eligibility.

### VA Claim Process (as applicable, if eligible)

If a Veteran or a family member is eligible for **both** a CLJA tort claim **and** a VA benefits claim, then:

 Before accepting a CLJA award B&M will determine and share with the Veteran whether an offset applies and its impact on VA benefits and care, if any.
