Overview of DIC

DIC is a tax-free monthly monetary benefit paid to an eligible surviving spouse or child of a deceased Veteran who either:

- Died while on active duty, active duty for training, or inactive duty for training
- Died from service-connected illness or disabilities (<u>38 U.S.C. 1310</u>)





Overview of DIC

- Had been rated totally disabled for 10 or more years immediately preceding death (including Individual Unemployability [IU] or 100% SC rating) or
 - continuously for at least 5 years from Veteran's release from active duty immediately preceding death; or
 - at least 1 year before death, if the Veteran was a former prisoner of war who died after September 30, 1999 (<u>38 U.S.C. 1318</u>)
- Death was the result of VA medical treatment, vocational rehabilitation, or compensated work therapy (<u>38 U.S.C.</u> <u>1151</u>)





DIC Inclusions

The only three types of DIC claims that we will accept* through the DRC Initiative are:

- the DIC claim is based on an already S/C connection condition
- the DIC claim is based on an already 1151 established condition
- The DIC claim is based on the 10 year rule

*The DRC portal is expected to be updated to accept DIC claims sometime in September.

The VSO submits a signed and completed VA Form 21-534EZ for DIC and a death certificate. The death certificate shows the death occurred on 06/15/2017 and the cause of death as coronary heart disease. The Veteran has been service-connected for posttraumatic stress disorder @ 100% and bilateral hearing loss @ 0% since 05/10/2002. The STRs are silent for coronary heart disease. The spouse, Martha, has been on the award since 05/10/2002 and was married to the Veteran until his death.

Is the claim DRC eligible and ready to submit?





Yes, the claim is DRC eligible as this is a claim for DIC based on a non S/C death with at least 10 years of S/C at 100% and the claimant is an eligible dependent.

All necessary evidence is of record in the DRC submission.





The VSO submits a signed and completed VA Form 21-534EZ for DIC and a death certificate. The death certificate shows the death occurred on 05/25/2017 and the cause of death as pneumonia. The Veteran has been service-connected for coronary artery disease @ 100% since 05/10/2016. The STRs are silent for any respiratory problems. However, the personnel records do show that the Veteran was a former POW during the Vietnam War. The spouse, May, has been on the award since 05/10/2016 and was married to the Veteran until his death.

Is the claim DRC eligible and ready to submit?





No, while the claim is a DIC grant and all necessary evidence is of record, the claim is not DRC eligible as the Veteran is only eligible for DIC based on being a POW and being S/C for 100% for at least one year prior to death.
