## **AUTOMATED PAYMENTS**

- Month of Death Checks
- Non-Service Connected Burial & Plot if Spouse listed on Award
- Service Connected Burial if Veteran was rated 100% SC or was IU for 10+ years and Spouse is listed on the award
- DIC payment if veteran was rated 100% for 10+ years or IU for 10+ years and Spouse is on the award

Initiated when the Veteran's award is stopped through FNOD



## VETERAN PENSION BENEFITS

### **Qualifications for Veterans Pension**

- 90 days or more of active military service, at least 1 day during a period of war. Effective September 7, 1980, must serve at least 24 months of continuous service (or entire period called to active duty)
- Discharged under conditions other than dishonorable
- Permanent and Total Disability (P&T) by rating, age 65 or older, in receipt of Social Security Disability, or in a nursing home
- Meets income and net worth guidelines



## SURVIVOR PENSION BENEFITS

### Qualifications for Survivors Pension

- Widow or qualifying child of a wartime Veteran with qualifying service
- Meets income and net worth guidelines
- Meets marital requirements as the surviving spouse
- Meets child requirements
  - Under age 18
  - 18 to 23 in school
  - Helpless before age 18



### SPECIAL MONTHLY PENSION

## Use VA 21-2680, Examination for Housebound Status or Permanent need for Regular Aid and Attendance

Signed by an Medical Doctor or equivalent

#### Housebound

Substantially confined to the home

#### Aid and Attendance

- In need of assistance of another person with his/her activities of daily living.
   i.e. inability to dress or undress, keep ones self clean, adjust prosthetic appliance, or bedridden.
- In a licensed nursing home receiving skilled or intermediate care (granted administratively, medical evidence of disability not required)



## What is Countable Income?

- Earnings
- Retirement income
- Interest
- Dividends
- Unemployment compensation
- Business income
- Life insurance dividends

It is the veterans responsibility to report income.

WHEN IN DOUBT, REPORT IT



# What is Not Countable Income for VA Purposes?

- VA Pension
- Profit from sale of primary residence
- Welfare (benefits received from social services)
- SSI (Supplemental Security Income)

WHEN IN DOUBT REPORT IT



# Medical Expenses

#### VA Form 21P-8416, Medical Expense Report is used to report the examples below:

- Abdominal supports
- Acupuncture service
- Ambulance hire
- Anesthetist
- Arch supports
- Artificial limbs and teeth
- Back supports
- Braces
- Cardiographs
- Chiropodist
- Chiropractor
- Convalescent home (for medical treatment only)
- Crutches
- Dental service, for example, cleaning, x-ray, filling teeth
- Dentures
- Dermatologist
- Drugs, prescription and nonprescription
- Gynecologist
- Hearing aids and batteries

### In-Home Care

Attendant affidavit to be filled out by caregiver or agency

- Specific services provided
- Who provides the services
- Frequency of services (daily, etc.)
- Amount paid for the services
- Contact information for provider
- signature



# Assisted Living vs Independent Living

Assisted Living Facility (ALF) means a facility designed to assist people who need help with daily activities.

Independent Living Facility (ILF) means a facility where people can generally live independently, and may or may not need help with daily activities.

- Date entered
- Projected length of stay
- Facility name
- Facility address and telephone number
- If Medicaid is covering part of the costs



# Medicaid \$90 Rate

- 38 CFR 3.551 (i) states VA must limit claimants to the \$90/month for a Veteran, surviving spouse or surviving child who:
  - Has neither spouse nor dependent child, and
  - Is in a Medicaid approved nursing facility, and
  - A Medicaid plan covers in part or all of the nursing home care.

#### Note:

- No overpayment is created when reducing to the \$90 rate
- The \$90 payment is for personal use and cannot be used to cover nursing home expenses
- Exception: not reduced to the \$90 rate if in a State Veterans Home
- Be sure to include the name and phone number of the facility
- If claimant has a running award, Due Process is initiated before \$90 rate is set.
- Only applies to a unmarried claimant



## How to Calculate VA Pension Rates

Annual Income

-Annual Medical Expenses

+ 5% medical deduction

= Income for VA Purposes (IVAP)

Maximum Annual Pension Rate (MAPR)

<u>-IVAP</u>

= Annual amount

Annual amount/12 = monthly amount



# Liberalizing Legislation

 Liberalizing Legislation is a law that allows VA to grant benefits up to one year prior to the Veteran's original date of claim

- Who is eligible?
  - A Veteran that is age 65 or older on September 17, 2001
  - Or has been in a Medicaid approved skilled/intermediate nursing home continuously since September 17, 2001
  - Or has been in receipt of Social Security Disability Insurance continuously since September 17, 2001
- Submit an Eligibility Verification Report (VA Form 21P-0516), Medical Expense Report (VA Form 21P-8416) and/or Examination for Housebound Status or Permanent Need for Regular Aid and Attendance (VA Form 21-2680) for one year prior to the date of claim

# Dependency and Indemnity Compensation (DIC)





## Definition

 Dependency and Indemnity Compensation (DIC) is a monthly payment made to a surviving spouse, child or parent because of a service connected death



# DIC Eligibility Requirements

- Veteran's death was in service
- Veteran was in receipt of 100% compensation for 10 years prior to death
- Veteran was rated 100% SC from date of discharge for at least 5 years
- Veteran's death was service connected
- Veteran was a POW who died after 9/30/99 and was 100% for 1 year prior to death



# Eligibility Requirements: Surviving Spouse

- Relationship must be established
- Continuous cohabitation must be shown
- Marriage must have been 1 year or have had a child born of vet during or prior to marriage.
- Death on active duty does not require 1 year marriage



# VA Form 21-534ez, Application for DIC, Death Pension and Accrued Benefits by a Surviving Spouse or Child

- Claim for DIC
- Claim for Death Pension
- Claim for Accrued Benefits





# Payment Rates

- For deaths prior to 1/1/93 rates payable based on highest pay grade held by the veteran for 6 months or more
- After 1/1/93 a uniform rate established
- An additional rate is payable if the veteran was 100% for 8 years and married to the widow for the 8 years prior to death



# SC death after 1/1/1993

- Basic monthly rate = \$1,257.95
- Add \$267.12 if vet in receipt of 100% rate for 8 years prior to death and spouse married to vet during those 8 years
- Add \$311.64 for each child under 18
- Add \$311.64 if spouse A/A
- Add \$145.99 if spouse is housebound
  - As of 12/01/2016



# A/A or Housebound rate

- A rating is required to establish A/A or housebound status for surviving spouse
- Submit completed VA 21-2680
- If in a nursing home, submit VA 21-0779



## **DIC Award Termination**

- DIC Death of claimant
- DIC Remarriage of surviving spouse(see next slide)
- Dependency Child over 18 and no longer in school or reaches age 23
- Dependency Marriage of child
- Dependency Child election of Chapter 35
   DEA benefit



# Remarriage of Surviving Spouse

- Effective January 1, 2004, when a surviving spouse remarries after age 57, DIC will continue.
- When a surviving spouse remarries before age 57, DIC payments stop.
- (Note: Beginning Oct. 1, 1998, DIC may be resumed if that marriage ends in death or divorce).





## Parents DIC

- Service connected death requirements are the same
- Is based on annual income with an income limit



## Other Benefits Associated with DIC

- CHAMPVA, unless already has Tricare
- Home Loan Guarantee
- Homestead exemption
- Civil Service Preference & FL. Veterans Preference
- Chapter 35 Education Benefits
- Commissary Privileges
- FL Homestead Exemption
- FL Scholarship for Children and Spouses of Deceased or Disabled Veterans



# Remarriage for DIC

- Age 55 reinstate CHAMPVA only;
- Age 57 reinstate DIC benefits



## **Burial Benefits**

#### **Types of Burial Benefits**

- Non-service connected (NSC)
- Service-connected
- Plot allowance
- Transportation allowance

#### **How to Apply**

- Submit VA Form 21P-530, Burial Benefits (within two years of death if NSC)
- Death Certificate (needs to show cause of death)
- Statement of Account (needs to show who paid the expenses and how much)
- Certified copy of discharge document (if Veteran was not receiving benefits)

## Non-Service Connected Burial

### **Eligibility:**

- In receipt of compensation or pension at the time of death
- Receiving military retired pay in lieu of compensation
- Had a claim pending at the time of death (found entitled)
- Died while under VA care

#### **Plot Allowance:**

- The Statement of Account is no longer required. However, it may show additional expenses such as the opening / closing fees that VA can allow
- VA will only pay the statutory limit or the amount actually paid for the plot expenses, whichever is lower



# Service Connected Burial and Transportation

#### **Eligibility:**

- Veteran died of a service-connected condition.
- Service-connected condition contributed to the cause of death
- Died of a presumptive service-connected condition
- Had a 100% service-connected evaluation prior to death

#### **Transportation**

#### Payable if:

- Veteran dies under VA Care, or
- If died of a non-service connected condition AND was in receipt of serviceconnected compensation AND is buried in a National Cemetery
- If died of a service-connected condition AND is buried in a National Cemetery
- Statement of Account is required



# Changes to Burial Benefits

#### Applies to claim received on or after July 7, 2014

- When "First to File" rule applies:
  - Spouse receives first priority for automated payments
  - VA will pay the first person or entity who files a claim that incurred the costs of the
     Veteran's burial
- Funeral homes may only apply if the Veteran's remains are unclaimed
- If the Veteran was 100% service connected at the time of death then service connected burial benefits are automatically paid



## **Automated Burial Process**

- Burial and Plot payments are automatically payable to the surviving spouse of record when the First Notice of Death (FNOD) is processed
  - FNOD can be processed by a call center, CVSO phone line, or other notification
  - If the Veteran was 100% service-connected at the time of death,
     service-connected burial benefits are automatically paid
  - Information available during FNOD process determines if plot is payable
- VA Form 21P-530, Application for Burial Benefits and supporting documentation is not required unless eligible for transportation and / or plot expenses

## **Accrued Benefits**

- Benefits due to the beneficiary but not paid prior to death
- Claim must be filed within one year of the death of the beneficiary
- No time limit for non-negotiated checks
- Can be eligible by Relationship or Reimbursement



## **Accrued Benefits**

#### Relationship

- Spouse
- Child(ren) for VA purposes
- Parent(s), if dependent on the Veteran at the time of the Veteran's death
- VA Form 21P-534 or VA Form 21-601 and a copy of beneficiary's death certificate

#### Reimbursement

- When no one is entitled by basis of relationship, anyone who paid expenses related to the beneficiary's last illness or burial
- VA Form 21-601, copy of beneficiary's death certificate and proof of paid expenses



## **Accrued Benefits**

**Substitution Appeal** – Veteran had an appeal pending at the time of death, will be worked by office with jurisdiction of appeal at time of death

**Substitution Claim** – Veteran had a claim pending at the time of death, evidence to support claim pending at the time of death may be submitted by substitute claimant

VA Form – 21P-0847 Request for Substitution of Claimant upon Death of Claimant
