

What's new at the RO?

Appeals Modernization Act(Simple, Timely & Transparent)

- Three review options for disagreements
- Improved notifications
- Earlier claim resolution
- Protects effective date



What's New at the RO Cont.

 DRC was cancelled – Hugh burden on the Service officers to complete all development upfront

 Discontinuation of RAMP, VBA will accept initial opt-in forms postmarked through 02/15/19.

BVA has taken over Scheduling of Hearing DVA

What's new at the RO Cont.?

 Case Flow - a web application that enables the tracking and processing of appealed claims at the Board of Veterans' Appeals

- No more reconsiderations; must be routed in the appropriate appeals lane or reopened
- IPC Portal (30-60 days behind)
- Sep 2018 VA stopped producing the 27 Series Letter

Issues

- POA changes when Veterans are scheduled for BVA Hearings.
- EOM claims/appeals submission
- Pertinent documents need to be upload into VetraSpec
- Fax limitation 10 pgs or less, please scan if you have the option



Issues Cont.

- Complete Intent to file
- Incomplete 21-22s
- Timely request for personal hearings (request for PMC must be sent to them)
- Notice of decision with incorrect instructions
